1. Biosolids Fees – Diker/Kieler
 - ✓ A fee history chart was distributed. See attachment.
 - ✓ Explanations were given as to how CDPH&E Staff determined the biosolids fee.
 - ✓ The fee to be assessed for the next three (3) years will be \$2.40 per dry ton of beneficially applied biosolids.
 - ✓ The biosolids program (Fund 128) is the only program billed based on actual dry tons of biosolids beneficially applied to land in Colorado. Since the program is, self funding, changes in the amount of monies received are quickly noticed and affect the program. It is estimated by the year 2012 there will be an excess of \$6 to 8,000 remaining in the fund. This is under the 16% of total program funds carry over limit.

2. Regulation No. 64 Rulemaking Hearing – Diker/Kieler
 - ✓ The rulemaking hearing for biosolids Regulation No. 64 is now set for February 2010.
 - ✓ Changes to Regulation No. 64 will be effective March 2010.

 - ✓ It was reported the school had approximately 127 participants primarily because the wastewater operators are on a three (3) year schedule for keeping their certifications current.
 - ✓ The school included a half day of biosolids training and a half day of water reuse training.
 - ✓ Next year a full day of biosolids training is planned.
 - ✓ The Committee is still working with ABC in regards to getting a RMWEA Biosolids Certification program up and running with the hopes that the State will adopt the certification.

 8. Biosolids as Solid Waste Considerations (NACWA)
 - ✓ EPA has proposed a rulemaking hearing that sewage sludge be regulated under the solid waste regulations.
 - ✓ The Beverage and Diamond law firm has been hired to work with NACWA on this.
 - ✓ Motivation is the Clean Air Act and sewage sludge incineration is the target.
 - ✓ September 12, 2009 is the mandated deadline EPA has been given to come up with a definition.
 - ✓ All members and interested parties are asked to keep ears and eyes open to developments on this proposal.
 9. 2010 Goals and Standing Rules – Foster
 - ✓ Read through Foster's email regarding Biosolids Committee Goals and Objectives 2009-2010 (see attached).
